
With reference to the above subject, it is requested to obtain willingness/choice of postings in following formats from Superintendents and Inspectors working under your formation:

2. The above letter may be circulated to all the officers concerned and acknowledgement may be obtained which is to be submitted to this office. However, giving of option of choice stations does not confer any right that they will be posted at the choice stations only. The transfer and posting will be done on the basis of existing transfer policy read with the Transfer Policy dated 20.07.2021 issued by CCO, Customs Gujarat Zone vide F.No. CCCO/II/(3)/18/2020-ADMN-O/o CC-CUS-ZONE-AHMEDABAD and vacancy position/Administrative viability. If no choice of station is given by the officer concerned, the officer may be posted anywhere within the jurisdiction of the Commissionerate. The officers due for sensitive charge should not give conditional option. If an officer wants to be considered for sensitive charge, then the condition on place of posting will not be entertained. It may also be noted that once the officer has opted for being considered for sensitive charge, no representation of forgoing the sensitive charge will be considered after the issuance of AGT-2021 orders.

3. Also, it is requested to send the History of Posting of the present Customs Tenure in respect of all the officers.

4. Please ensure that the above information is submitted to this office positively by 10.08.2021. Please note that no representation will be entertained after the stipulated date.
