Please refer to subject Show Cause Notice No. **ADC-04/2023-24** dated **25.09.2023 issued to M/s. Vansh Traders and Exporters, Maharashtra** by Additional Commissioner, Customs(Preventive), Jamnagar Commissionerate.

2. Due to outbreak of COVID-19, the Central Board of Indirect Taxes and Customs has issued detailed guidelines for conducting personal hearing in virtual mode through video conferencing vide letter F. No. 390/Misc/3/2019-JC dated 21.08.2020. The Board vide letter dated 28.07.2022 has amended the said instructions and it has been decided to grant virtual hearing only at the request of Noticee. However, hearing will be conducted in physical mode for the Noticee not opting for virtual mode.

In this connection, I am directed by the Adjudicating Authority i.e. Shri Harkirpal Khatana, Additional Commissioner, Customs (Preventive), Jamnagar to inform you that **personal hearing in the above matter in physical mode is fixed on 15.02.2024 at 13.00 hrs. at above address.** However, if you wish to opt for virtual hearing, intimation in this regard should reach this office latest by 12.02.2024 along with name, copy of Photo ID, contact numbers, valid e-mail id and Vakalatnama of the authorised representative who wish to attend it.

4. It is on record that the said Show Cause Notice dated 25.09.2023 has been dispatched to you. However, this office has neither received reply to Show Cause Notice nor any request for extension to file reply to Show Cause Notice despite lapse of specified time period of 30 days. Hence, you are requested to file your reply to the subject Show Cause Notice on or before **12.02.2024**. It is pertinent to mention here that the case would be decided ex-parte on merits on the basis of records available in case of non-receipt of your reply to the Show Cause Notice dated 25.09.2023 and/or non-appearance for personal hearing.
