
2. The Food Safety and Standards Authority of India has been established under the provisions of Food Safety and Standard Act, 2006 as statutory body for laying down science based standard for articles of food and to regulate manufacture, storage, distribution sale and import of goods so as to ensure availability of safe and wholesome food for human consumption. Under the Food Safety and Standards Act, the Food Authority has a mandate of ensuring safety of food items imported into the country.

In the pursuant to Annual General Transfer 2019 in terms of provisions contained in Section 25 read with Section 47(5) of FSS Act, 2006 and in pursuance with the Order dated 02.05.2018 issued by the Chief Executive Officer, Food Safety and Standards Authority of India, New Delhi vide F. No. 11371/FSSAI/Imports/2015 (Part-7), the following officers are hereby notified as the Authorised Officer for clearance of imported food items with immediate effect and till further orders in respect of following ports under jurisdiction of CCP Jamnagar as detailed below:
