Bhavnagar) (hereinafter referred as "the applicant") had requested to furnish the information under the Right to Information Act, 2005 (hereinafter referred to as "the RTI Act"). In this context, it is to inform you that departmental disciplinary proceedings for prosecution of criminal offence as well as judicial proceedings are going on against Shri D. P. Makwana, Superintendent. In this context, attention is invited to section 8 (1) (h) of the RTI Act, 2005 which states that "Notwithstanding anything contained in this Act, there shall be no obligation to give any citizen - Information which would impede the process of investigation or apprehension or prosecution of offenders". Since, the information sought for may impede the process of investigation or apprehension or prosecution of offenders, the same is exempted from disclosures in terms of the section 8 (1) (h) of the RTI Act, 2005.
