and 2015 for import of machines.

2. If the answer to Question 1 is yes than please provide details of the license along with duty saved and export obligation.
3. How much export Maxan Corporation Private Limited has done and what is the current outstanding.
4. Is the period for doing export completed and Maxan Corporation Private Limited has applied for extension.
5. Has DGFT or Indian Customs has filed claim in Case No. RP No. 492/2018 (OA No. 270/2017) at DRT 2, Ahmedabad filed by bankers of Maxan Corporation Private Limited. Auction scheduled on 15.11.2022.
6. What is the amount payable by Maxan Corporation Private Limited to DGFT or Indian Customs.
