**(ORDER UNDER SECTION – 7 (1) OF THE RIGHT TO INFORMATION ACT, 2005)**

Shri Rananjay Pratap Singh, Quarter No. 7, Type-IV, Central GST Officers Colony, Race Course Ring Road, Rajkot, Pin: 360001 (hereinafter referred as "the applicant") vide online RTI application (Registration No. CCCGZ/R/E/22/00073 dated 30.10.2022 has sought the information under the Right to Information Act, 2005 (hereinafter referred to as "the RTI Act"). The said RTI application is received through online RTI Portal in this office on 31.10.2022 to furnish the information as per the RTI Act, 2005.

In this context, the information sought by the applicant Shri Rananjay Pratap Singh, is as under:

**Para 1 to 3:** The application was forwarded to Vigilance Section and Establishment Section. It has been replied that the matter does not pertain to their sections. The applicant has not mentioned as to how and to whom the said letter dated 25.04.2022 was delivered (i.e. by post / inward / particular email address etc.). The information sought is ambiguous and without proper references. In absence of specific details, the matter cannot

be processed further for giving reply.

**Para 4 and 5:** No action has been taken on the letter dated 13.04.2022 (though it is marked as Through Proper Channel, received directly in Vigilance Section) and in letter dated 23.05.2022 allegations have been made to target the officers of Vigilance Section.

**Para 6:** It is not forthcoming that which type of information is sought in the RTI. The information sought is ambiguous and without proper references. In absence of specific details, the matter cannot be processed further for giving reply.

**Para 7:** Due action on letter dated 17.10.2022 has been taken and the same has been informed to the Deputy Commissioner, Customs Division, Jamnagar.

**Para 8:** Vigilance status is being informed to the individual at the appropriate time.

**Para 9 to 11:** The information sought cannot be provided in terms of Section 8(1)(h) of the RTI Act, 2005.
